# What Is the Equality Act?

"The Equality Act would amend the Civil Rights Act of 1964 to include the entire array of relationships, and behaviors, and identities, known as LGBTQ, and to put those identities alongside, for example, race and gender as protected classes against whom there could be no discrimination in employment, in education, in public funding."

"[Christianity Today]: How does the Equality Act differ from existing legislation regarding sexual orientation and gender identity?

[Shirley Mullen]: First, it raises the protection of the LGBTQ community to the federal level. This affects federal funds and would be a national mandate; right now, they are negotiated at the state level.

The most significant part of the Equality Act is actually what's not in it, which is the protection for religious freedoms that has always been an understood part of the American Constitution. It removes the traditional religious freedom protection provisions that have always been part of the Constitutional discussion. This would be the first major piece of legislation that excludes explicitly protection for religious freedom.

It would remove the potential for dialogue to continue between the rights of the LGBTQ community and the traditional rights of religious freedom. [...]"

# Would religious institutions be impacted?

"The *Equality Act* defines *public accommodation* as 'including restaurants, senior centers, stores, places of or establishments that provide entertainment, health care facilities, shelters, government offices, youth service providers including adoption and foster care providers, and transportation.' As a result, the definition of public accommodations could be interpreted to include churches and thereby, making it illegal for both non-profit and for-profit businesses to be misaligned in practice with government regulations regarding sexual orientation and gender identity."

"How might the *Equality Act*'s change to *shared areas* and *public accommodations* impact churches? Currently, houses of worship that offer services to the public like food pantries, biblical counseling ministries, homeless shelters, domestic violence shelters, and other such ministries are not seen as *public accommodations*. Under the *Equality Act*, there's a chance these types of services offered by and operated by churches would be viewed as public accommodations (especially if such service/outreach ministries receive federal funding—and possibly even if they don't receive federal funding)."

"The solution the CCCU is proposing: Fairness for All, federal legislation that would protect religious liberties for institutions while at the same time offering certain civil rights to LGBT people. The idea came from Mormon-dominated Utah, which was hailed in 2015 for passing compromise bills banning forms of LGBT discrimination but also codifying rights for religious expression."
